**MEMORANDUM OF ASSOCIATION**  
**OF**  
**SAKAR SOCIETY FOR DIFFERENTLY ABLED PERSONS**

1. **Name of Society** : **SAKAR SOCIETY FOR DIFFERENTLY ABLED PERSONS.**

2. **Regd. Office** : Vill. - Salah near Dental College, Teh. Sunder Nagar, Distt. - Mandi (H.P.)

3. **Area of Operation** : Whole State of Himachal Pradesh

4. **Aims & Objectives of the Society :-**

- a) The name of the Society is **SAKAR Society for differently abled persons.**
- b) The area of operation of the Society shall be in Himachal Pradesh.
- c) To work in disability field.
- d) To provide the best education to the disabled persons of the School with the aid of modern equipment and with the help and guidance of the best suited staff-members amidst the modern and best suited staff-members amidst the modern and best surroundings to enable the students to develop their skill and helping them to become self dependent.
- e) To generate the ideals of good citizenship, disciplined life and good moral character.
- f) To establish maintain, run rehabilitation Centers/Schools/Polyclinic/Training center to provide technical, vocational scientific and industrial training and education to disabled.
- g) To establish, maintain and manage residential quarters, hostels and other buildings for providing facilities for trainees, faculty members and other related persons.
- h) To receive contributions, donations and charities from any person and or any firm, Corporation, local body or authority or Government or any other institution for the purpose of the Society.
- i) To help maintenance religious harmony among various communities and discipline.

- j) To establish and coordinate a good relationship amongst members of the Society.
- k) To enter into any agreement with any government or authority, State, Municipality, local body or any person with a view to obtain from them rights, privileges, concessions as may be deemed desirable for obtaining the objects of the society.
- l) All income of the Society shall be utilized towards the promotion of the aims and objectives of the Society.

5. Rules, Regulations and Byelaws of the **SAKAR Society for differently abled persons:-**

**A) Membership & Miscellaneous :**

**All the members of the Society should be :-**



- i) He must have a good moral character.
- ii) He must be an honest man or women.
- iii) He must not declare to be bank corrupt.
- iv) He must not be declare/found guilty punish or penalized of any offence by any court of competent jurisdiction situated within or outside in India.
- v) He must possess ~~will~~ knowledge of performing social affairs.
- vi) He must be competent to make a contract according to the provisions made under the Indian Contract Act, 1972.

**B) Meetings of the Society:-**

- i) The meeting of the governing body shall be held at least once in ~~three~~ months or ~~four~~ meetings in a year.
- ii) General body meeting will be held once in a year with at least one half of total members of the Society.
- iii) General Secretary will be responsible to intimate all the members through all the possible means of communication for any purpose.
- iv) All the meetings will be presided over by the President.
- v) In the absence of President, the Vice President/Secretary has to preside over the meeting.

**C) General body (Powers, Functions and Duties):-**

- i) The general body will be constituted by all categories of the members.
- ii) The General body meeting will be held once in a year as per provision of section 19 of H.P. Societies Registration Act, 2006.
- iii) In general body meeting decision will be taken on majority basis. The President also has right to vote for it.



**D) Governing body (Powers, Functions and Duties) :-**

- i) The governing body will not comprise of less than five members.
- ii) The governing body shall at least elect a President, Vice President, Secretary, Cashier and Coordinator in order to run the Society smoothly.
- iii) **The terms of the general body will not be more than three years in any case.**
- iv) The governing body shall be executive authority of the Society and will undertake all the activities of the Society.
- v) There will be no salary for members of the governing body.
- vi) The Power of planning, monitoring, investment, approval, audit and legal actions will be with the governing body.

**E) Powers, Functions and Duties :-**

- i) **President :** That the President shall be elected by the members of the Society.
- Duties :-**
  - aa) The President shall conduct the affairs of the Society. He will be leader of the Society. He will preside over all the affairs of the Society.
  - ab) He will maintain discipline between the Society and its other officers and members.
  - ac) Whatever would be beneficial or in favour of the Society and be passed with the common consent of other active members with majority, shall endeavour to apply in practically.

ii) **Vice-President :** The Vice-President shall be elected by the members of the Society in General meeting.

**Duties :** aa) In the absence of the President, the Vice - President shall perform all the duties of the post of the President. It power are given specifically to the Vice-President, in writing by the President, of the Society.

iii) **Secretary :** The Secretary shall be elected from the Executive Committee which would be acceptable to all other.

**Duties :** aa) The Secretary shall summon the meetings etc. of the executive committee/Society He shall keep the every record safely of every decision taken place in the meeting etc. of the Society. He shall help the President and in case of President's absence, the Vice-President in performing the duties of the Society.

iv) **Cashier :** aa) The Cashier shall be elected in general meeting with the common consent of all.

**Duties :** He shall keep the records of every expenditure and all the sources of income of the Society.

**F) Membership of the Society :**

- i) Membership is open to all the resident of H.P.
- ii) Every member of the Society will have to deposit a sum Rs. 1100/- as entry fee once in life and monthly subscription of Rs. 10/- only.
- iii) If a member fails to pay monthly subscription of Rs. 10/- continuously for a period of six months, his membership shall be treated as cancelled.
- iv) The membership can be renewed after paying arrears alongwith Rupees 500/- as renewal fee.

**G) Bank Account :**

- i) Bank account of the Society shall be opened in the Nationalized Bank.
- ii) Bank account will be operated by the cashier or general secretary with the consent of the president.

**H) Audit :**

- i) Audit of the Society will be conducted once in the year.



**I) Decisions :-**

- i) Generally, all the decisions will be taken under the provision of H.P. Societies Act, 2006 unanimously with the consent of all the members. In case of any conflict/contradiction, the decision of the president will be considered as final.

**J) Circulars/Resolutions :-**

- i) All the circulars/notes and resolutions will be communicated to all the members concerned with all possible means of communication. The Governing body shall put resolutions and pass it with majority of the members. All the consents of the members will be entered with the drafted statements which are get sign by all the present members.

**K) Investments :**

- i) The governing body shall be entitled to authorized and invest the funds/money of Society for Public Welfare, subject to the provision of the income tax Act 1961 and these presents if any securities or investment immovable property which all be made strictly in the name of Society and shall be held in the office of the Society or as desired by the board of governors.

**L) Dissolution :-**


